SWALLOWED

100% Pure NAA and IBA - LD50 - orally in rats: 1.0g/kg. Undiluted ESI-ROOT contains 3.2g/L of IBA/NAA combined, therefore may cause irritation to the gastro-intestinal tract, or cause pain and vomiting.
